- **1. Welcome and Apologies:** David welcomed the Group. Apologies from Hilary Crewes.
- **2. Minutes of Meeting**: **August 5**th **2019**. **Matters Arising**: The Minutes were agreed. Some actions have been completed with the remainder to be discussed as Agenda items. Peter F is continuing to work on consultation with local firms and businesses.

3. NDP Document – Proof Reading, graphic design & printing:

David confirmed the draft plan had been updated with a section on habitat and biodiversity. Peter F has been proof reading the NDP document and the accompanying landscape character assessment documents.
